Personal data I process

SanaRoots processes your personal data because you use my services and/or because you have provided this data to me yourself. This information is used to contact you in order to create a *Child in Mind* attunement.

Retention of personal data

Your personal data will not be shared with third parties. Data collected for creating a *Child in Mind* attunement is retained for three months. After three months, all personal data are permanently deleted

Special and/or sensitive personal data processed

My website and/or services do not intend to collect data about visitors under the age of 16, unless they have permission from their parents or guardian. However, I am unable to verify whether a visitor is older than 16. I therefore recommend that parents be involved in the online activities of their children in order to prevent data from being collected about minors without parental consent.
